The school undertakes to able by the provisions contained in the affiliation & examination byelaws directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and labor Laws etc. with respect to the school and staff of the school

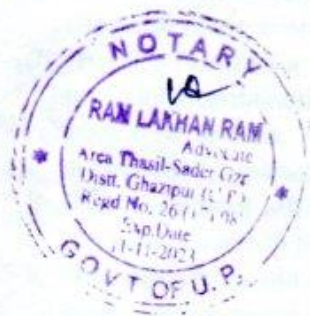
10. That the school will ensure that sufficient numbers of qualified teachers as per the provision contained in affiliation bye laws are available with the school before starting classes.
